# **General Membership Meeting Summary**

The Chairman, Troy Erbentraut started off the second meeting of CIL-CARP by introducing Stop the Bleed. The goal of the grant project is to provide tourniquets to police, fire, EMS, hospital emergency departments, and schools. In order to more cost effectively in purchase of the kits, Troy is assessing what equipment is currently being used by the aforementioned agencies and in what quantity.

Chris Miller of the NWS and Brian Gustafson, Rock Island County Coroner, presented on their respective fields. Chris Miller spoke on the different natural disasters that impact Illinois along with details and specifics surrounding each disaster. An important takeaway from his presentation is that although it appears that severe weather is becoming stronger and more frequent this can be explained through increase in population density or urbanization and advancement in storm spotting capabilities.

Brian Gustafson brought to view what a coroner does and how they prepare for mass casualty incidents. This involved identifying potential targets, including natural disasters, his resources, and MOUs. A significant point to be taken from his talk was the different areas of importance when properly handling the deceased, such as different types of religions. As mentioned by him, funeral directors are a great resource to tap when trying to understand how to respectfully handle or approach incidents involving the deceased.
